 - ii. St. A received \$493,971.05 and has spent \$384,906.70 to date
 - iii. Purchases must be approved by Hamilton County Education Services
 - iv. Used to purchase cafeteria tables, activity tables and many enhancements for technology
 - **b.** Enrollment Update
 - i. Enrollment numbers for next year looking good...will meet or exceed this year's enrollment
 - ii. Only losing 2 students (1 Kindergartner who has siblings at Visi and 1 to Walnut Hills)
 - iii. Kindergarten will be full day only starting next year; no 1/2 day K
 - c. New Student Probation Policy will start next year
 - i. Applies to any new student 1st grade and up (K is excluded), whether they start at the beginning of the year or mid-year
 - ii. Intended to make sure St. A is a good fit for new student
 - iii. Parents will sign a contract agreeing to the 6 week probation period
 - **iv.** New students will be evaluated after 3 weeks and again after 6 weeks on the following criteria: attendance, academics, behavior
